The Fairfax County Democratic Committee employs one full time employee, the Executive Director, who did not spend more than 25 percent of their time devoted to federal elections and candidates during this reporting period. No other entity pays compensation for their employees to work for the Committee. The Committee does not engage in any fundraising on behalf of candidates for Federal office, so all of its reported fundraising expenses are party fundraising. The Committee maintains both Federal and Non Federal accounts. The Committee is allocating administrative expenses using the 21% - 79% split this year.
