Because we relied on the vendor to some extent in preparation, and do not have a firewall in place, we cannot rule out an inadvertent act of coordination having occurred. Upon consultation with our FEC Analyst, we are reporting this transaction as memo text on line 21(b) and as a contribution on line 23 (to FRIENDS OF RAY).
