Unless otherwise noted, none of the expenditures reported are allocable to a candidate. The Calendar Year To Date Per Election Office Sought (General, Presidential) totaled \$513,589.66 on the final 24-hour filing prior to the election. The Calendar Year to Date Per Election Office Sought (General, Presidential) on the 30-Day Post Election filing totals \$500,416.91, a difference of \$13,172.75. The committee reported an Independent Expenditure on 10/24/2012 payable to Campaign Headquarters for \$4822.75. The reported amount was an estimate for services that were not used. Therefore, the expenditure is not included in this filing. In addition, the committee reported Independent Expenditures on 11/1/2012 payable to Engage for \$43,752.75 and the actual amounts incurred were \$35,402.75, a difference of \$8,350.00.
