On 02/27/23 a fraudulent check, created by an individual not associated with the Business Industry Political Action Committee (BIPAC), posted to BIPAC's primary checking account at PNC Bank. The fraudulent check, in the amount of \$14,156.89, was a forged image of a BIPAC check and not an actual check used for business purposes. Upon discovery of the fraudulent activity on 02/27/23, BIPAC immediately took the following steps: 1) PNC Bank was notified of the fraudulent check and in turn opened an investigation. 2) BIPAC's primary checking account, on which the fraudulent check was drawn, was frozen and a new checking account was opened with additional security measures implemented for check payment approval. 3) BIPAC provided PNC Bank with a notarized affidavit detailing the fraudulent activity. 4) BIPAC filed reports with the US Postal Inspection Service and the Washington, DC Metropolitan Police. PNC Bank returned the funds in question, \$14,156.89, to BIPAC's account on 02/27/23, the same day the fraudulent check posted. For reporting purposes, the fraudulent check has been itemized on Disbursement Line 29 while the recoupment of funds appears on Receipts Line 17.
