


Thank you for speaking with me over the phone regarding the filing of the FEC Form 2: Statement of Candidacy.

For reports shipped via delivery services (e.g., FedEx, UPS or DHL), use the ZIP code 20002.

If a statement or report is sent by registered mail, certified mail or overnight mail with an online tracking system, it is considered filed on the date of the U.S. postmark. If a statement or report is sent by first class mail or hand delivered, it is considered filed on the date it is received by the Federal Election Commission.

The committee should retain evidence that it delivered the report to the U.S. Postal Service or the overnight delivery service, in the event of a delivery failure.

You mentioned that you will be using FECFile to submit your July Quarterly Report due on July 15th. For help with using FECFile, please consult our ["Getting Started with FECFile User Manual"](#) and watch the [FECFile video tutorials](#).

When using FECFile, **please be sure to save your committee file often and back up your file to an external hard drive**. The FEC does not have access to your committee file, so if your file is lost, you will need to re-enter and/or re-import all of your data.

As discussed in our phone call, it is recommended that you electronically file a Form 99 (Miscellaneous Report to the FEC) that contains the same information required for the Form 2 (candidate name and address, party affiliation, office sought, state, and the name and address of your principal campaign committee). A Form 99 can be filed using the [online webform](#) or FECFile. Please see [page 11 in the FECFile Getting Started Manual](#) for instructions on how to electronically file a Form 99.
