If a statement or report is sent by registered mail, certified mail or overnight mail with an online tracking system, it is considered filed on the date of the U.S. postmark. If a statement or report is sent by first class mail or hand delivered, it is considered filed on the date it is received by the Federal Election Commission.

The committee should retain evidence that it delivered the report to the U.S. Postal Service or the overnight delivery service, in the event of a delivery failure.

You mentioned that you will be using FECFile to submit your July Quarterly Report due on July 15th. For help with using FECFile, please consult our <u>"Getting Started with FECFile User Manual"</u> and watch the <u>FECFile</u> video tutorials.
