This letter is in response to your request for additional information date April 6, 2023.

1.Your letter indicates that the Committee disclosed contributions that appear to exceed the limits set forth in the Act:

William Allred: A chargeback in the amount of \$250 was processed thru Winred on 1/21/23. This was disclosed on the April 15, 2023 Quarterly Report.

Terry Athas: Two chargebacks totaling \$500 were processed thru Winred on 1/21/23. These were disclosed on the April 15, 2023 Quarterly Report.

Larry Davis: A refund in the amount of \$420 was issued on 1/9/23. \$127.50 was redesignated to the 2026 General on 1/5/23. These were disclosed on the April 15, 2023 Quarterly Report.

Kenton Hamaker Jr.: A chargeback in the amount of \$250 was processed thru Winred on 1/3/23. A chargeback in the amount of \$250 was processed thru Winred on 1/21/23. 2.Your letter indicates that the committee disclosed an excessive contribution from a non-qualified political action committee:

Alynlam Pharmaceuticals Inc. PAC: The contributing PAC did not inform the Committee that they were not a qualified political action committee. However, \$2100 was transferred from primary 2026 to general 2026 on 12/18/22 and included on the 3/31/23 distribution from McConnell for Majority Leader. This was disclosed on the April 15, 2023 Quarterly Report.

3.The Statement of Organization was amended on 5/11/23 to add the Republican Senate Victory 2022 as a joint fundraising representative.
