In compliance with 11 CFR 300.32c2, Dallas County Republican Party Primary Committee reports the expense for the employees salary on H4 because they spend less than 25% of their compensated time on Federal Election Activity . Volunteers from Dallas County conduct activities such as voter identification, voter-registration, get-out the vote, and other generic campaign activities. Mileage Reimbursements are for travel for Committee Party Building business and not FEA activity. Transfers from the nonfederal account to pay the nonfederal portion of an allocable expense are made within a 70-day window: no more than 10 days before or 60 days after the day the federal account (or allocation account) makes the payment. 106.7(f)(2). The Committee reports expenses on Schedule H4 for prior year period using the 36 and 64% ratio applicable for this Committee. Also reported are expenditures using the new ratio of 15 and 85% for this Committee new election cycle. Allocated Transfers reported on H3 include \$5,028.03 for prior year expenses. The excess contribution from Darwin Deason on February 10, 2021, in the amount of \$15,000, with permission from the donor, was transferred to the nonfederal account on March 5, 2021. While preparing the April Monthly Report, we identified an error on the original March Monthly report.
