Dear Sir or Madam:

Americans Against Illegal Immigration is a relatively new political action committee which filed as of July 11, 2005. In spite of our best efforts to comply with the FEC's electronic filing requirements, we are not able to do so at this time. We did reach the \$50,000 threshold in the last year.

In our attempts to use the FEC's own online software, we encountered difficulties with which we believe any computer user of ordinary skill and ability would have trouble.

Among them, and certainly not limited to them, were:

- Cannot find a means of listing itemized disbursements for Schedule B;
- Inaccurate totaling process when itemized donors (\$200.00+) have been entered;
- Inaccurate listing once entry is made of loans received and loan payments made;
- No means of finding access to list unitemized donations;
- Inability to access summary page for items 1 through 5 ;
- No explanation found in searching for "help" that indicates how the treasurer's name and electronic signature can be affixed for Fields 106 and 107. Our password is "oceanview".

In a good faith attempt to comply with today's January 31<sup>st</sup> deadline for our year-end report, I have enclosed a hard copy with such information as we could input and print.


Yes, we have sought help by telephoning your office. One call was returned last week. Others made (yes, understandably at the last minute) have not, as yet, been returned.

It seems your system is very complicated. Perhaps established political committees have the financial resources to hire outside, professional talent to accurately complete and electronically file Form 3X. We, as yet, do not.

We will file an amended report with full and accurate information if someone can provide guidance to our Executive Director, Allen Brandstater, who is responsible for the preparation of financial data for my review and signature.
