This payment was made via check that was issued on September 12, 2018, but was not cashed until October 30, 2018; because of the gap between the payment and the cashing of the check (which was not reflected on bank records available as of October 15, 2018), an amended report was required to properly reflect the September 12, 2018 payment date. As the Commission will see, the salary payment is equal in amount to the salary payment made in October 2018, reflecting Mr. Gottlieb's monthly salary for that period of the election cycle. The withholding of payroll taxes associated with that payment was disclosed in the initial October quarterly report (reflecting withholding by ADP of \$13,510.82 on September 11, 2018). An amended October 2018 Quarterly report was prepared at the time of the preparation and filing of the Post-General 2018 filing, but inadvertently was not filed because of lack lack of familiarity with the FEC File e-filing system (i.e., the underlying numbers were updated at that time, but only the Post-General report was filed, rather than amended versions of the October Quarterly 2018 and Pre-General 2018 reports).
