To Whom It May Concern,

On March 21st, 2014, I filed the necessary paperwork with the Federal Election Commission and the Internal Revenue Service to launch a political action committee named "Vote for the Other Guy PAC" (FEC ID: C00560060).

The intention of this committee was to persuade the public to vote out all incumbents in the 2014 Congressional elections. The means by which I intended to fund the PAC's work was through a crowd-funding campaign on the crowd-funding site indiegogo.com. My intention was to raise \$100,000 to produce a series of online videos and social media content through which to disseminate the PAC's message. I ended up only raising \$985.00 (\$250 of which were actually an anonymous donation from myself, to spur interest in the crowd-funding campaign).

Because I fell so short - so short! - of my fundraising goals, I decided to to return the money of those who made a donation, and to cease operations of my PAC. I did not attempt to raise any more money, I did not spend any of the money that I raised (because I returned it), and as such, the PAC has no outstanding debts or recorded expenditures. Subsequently, I also did not file any quarterly reports with the FEC or the IRS."

I recently called the FEC to inquire about the steps necessary to shut down the PAC, and to find out if I need to file any reports for the year of 2014. I was advised that, because I raised so little money (which I subsequently gave back), and because the PAC had no expenditures or debt, that the best course of action would be for me to send a letter to the commission, outlining my actions, and requesting that the PAC be shut down. Through this letter, I am making such a request.

My PAC produced no content, spent no money, undertook any debts, or executed any actions revolving around the 2014 Congressional election. If there is any additional information or filings that you need from me, please let me know what those are, and I will promptly provide them for you. Otherwise, I will consider this matter closed.
