
Enclosed please find the Q1 2014 report for Resounding Books PAC (FEC ID # C00541631).

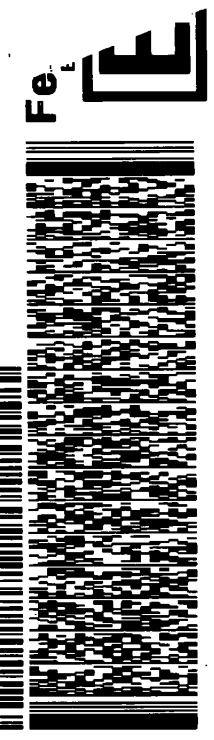
