I tracked it and USPS says it was delivered to "front desk, reception area, or mail room at 11:58 am on 7/18/2025 in Washington DC" However, my FEC account is not showing this FEC Form 3 for Q2 of 2025. I needed to file an amended return because we have since contracted with ISP to help with our financial recording and filings and we have found some errors. But because my first filing is not showing, I cannot file an amended report so ISP recommended I file this as a first filing - even though it is not and I filed before the deadline. So this is the correct FEC Form 3 for this campaign for Q2 of 2025. Please accept with no late filing penalty as I originally filed in time, the FEC just has not recorded it yet.
