This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

Since the state of Louisiana did not hold a runoff or general election in 1998, any contribution(s) so designated by your committee must be returned by the candidate committee or redesignated by your committee in accordance with 11 CFR§ 110.1(b).

If the contribution(s) in question was incompletely or incorrectly disclosed, you should amend your original report with clarifying information. If you have made a contribution for the general election in the state of Louisiana, you should notify the recipient and request a refund of the full amount of the contribution(s) and/or notify the recipient in writing of your redesignation of the contribution(s). In the best interests of your committee, all refunds and redesignations should be made within sixty days of the treasurer's receipt of the contribution(s).

Please inform the Commission of your corrective action immediately in writing and provide a photocopy of the refund request sent to the recipient committee(s). In addition, any refunds should be disclosed on Schedule A

supporting Line 16 of the report covering the period during which they are received. Any redesignations should be disclosed as memo entries on Schedule B supporting Line 23 of the report covering the period during which the redesignation is made. 11 CFR §110.1(b)

Although the Commission may take further legal action regarding this contribution(s), prompt action in obtaining a refund and/or requesting a redesignation will be taken into consideration.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
