2. On Schedule(s) A of your report you have disclosed a transaction(s) for \$0.00. For your information and consideration when preparing future filings, only transactions with an actual monetary value should be itemized on your report. If the amount for this transaction(s) was entered in error, please amend your report to include the correct amount(s). (11 C.F.R. §104.3)
