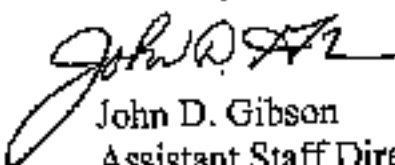
Dear Mr. Anthony:

This letter is to inform you that as of April 3, 2002 the Commission has not received your response to our requests for additional information dated March 13, 2002. These notices request information essential to full public disclosure of your federal election campaign finances. To ensure compliance with the provisions of the Federal Election Campaign Act (the Act), please respond to these requests (copies enclosed).

An adequate response must be received at the Commission by April 24, 2002. Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. **Requests for extensions of time in which to respond will not be considered.** Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended. This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Schedule B supporting Line 29 of your report discloses what appears to be an internal transfer. Please note that the reporting of such transfers affect the cash balance of your report and do not need to be reported. Please clarify if this is such a transfer and, if necessary, amend your report accordingly.

-Line 23 of the Detailed Summary Page of your report discloses a total of \$4,500 in contributions to federal candidates/committees. The sum of the entries itemized on Schedule B, however, indicates the total to be \$5,000. Please amend your report to clarify the discrepancy.

A response or amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter. Electronic filers must file amendments in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
