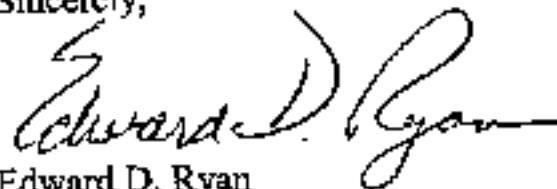
This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

Please clarify the contribution(s) and disclose any redesignations or refunds as necessary on the appropriate schedules.

-Schedule B supporting Line 23 of your report discloses a contribution to Leadership 2,000; however, you have disclosed "Rep. Oxley's Leadership PAC cont. ROHO4" in the purpose of disbursement field. Please clarify whether this was an earmarked contribution made by your committee through the Leadership 2,000 committee to this candidate, or if you made the contribution to the political committee exercising no direction or control over how the funds were to be used. If the latter is the case, please do not include the candidate's name in the purpose of disbursement field on future reports.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
