Approximately one year ago I agreed to take over reporting for the PAC of our very small trade association. In the four years since we established the PAC we have amassed a total of four contributors and made disbursements totaling \$3,275 to three federal candidates. But we have been significantly behind in our reporting requirements and I take responsibility for that.


Over the recent holidays I have been able to assemble our accounting, determine the status of our reporting and educate myself on the FEC reporting requirements and procedures. This mailing contains the following items and I believe it brings us up to date on our filings.

1. An amended FEC Form 1 establishing me as the Treasurer, allowing me to submit the filings under my signature.
2. Amended MY and YE filings for 2015 to correct a \$500 discrepancy in our contributions.
3. Q1, Q2, Q3, YE and 30G filings for 2016
4. MY and YE filings for 2017

Also, please note that the FEC filings database incorrectly provides a "coverage end date" for DWEA PAC's 2014 30-day Post-Election filing (FEC 1034354) as 11/24/2015.

We intend to meet all future deadlines for filings and beg forgiveness for our past failures.

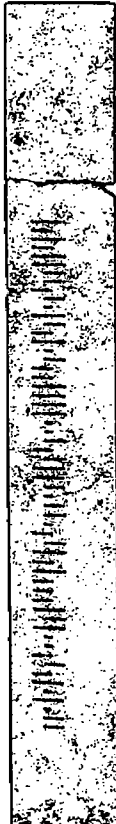

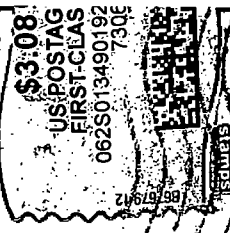
