-Payments made to credit card companies must identify in memo entries, the original vendors from which you have purchased an item or service if your payments to these vendors have exceeded \$200 this year. Please amend your report by providing the mailing address, date, amount and purpose of such payments as required by 11 CFR §104.9(b).

-Schedule B supporting Line 23 of your report discloses a contribution(s) to a federal candidate(s) for "Debt Retirement" (pertinent portion(s) attached). Please provide the election year this contribution(s) should be attributed to.

Any amendment or clarification should be filed with the Federal Election Commission. Electronic filers must file amendments in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that
