With respect to the January 2003 'Other Disbursement' in the amount of \$12,500.00: In August of 2001, the former treasurer, Cynthia L. Martin, closed-out the account at Grand Bank by cashing two checks made payable to DRS Technologies GGF in her own, personal account. She claims to have then obtained Cashiers Checks in the amounts of \$5,000.00 and \$7,500.00 and mailed them to the current treasurer. It was discovered in January 2002, while preparing the Year-End Report of Receipts and Disbursements, that these two checks were not received with the other transferred materials. Upon contacting Ms. Martin, she claimed to have contacted her bank and indicated that the bank policy was not to re-issue replacement cashiers checks until a year had elapsed. At the end of that year, Ms. Martin was again contacted (August of 2002). She claimed to have gone to the bank, obtained replacement checks, and that the replacement checks would be forwarded directly. When the alleged replacement checks were not received, attempts were made to contact Ms. Martin and every attempt failed. Additionally, all subsequent attempts have failed. While attempts to contact Ms. Martin will continue, DRS Technologies GGF is writing-off this money from the Internal ledger and thus making a disbursement to Ms. Martin. Should efforts to reclaim this money be successful, the PAC will include this item as an 'Other Receipt' at that time.
