Dear Ms. Denny,

After we spoke on Wednesday, December 16, it became clear to me that the letter I had sent you concerning Tribal Sovereignty PAC's Statement of Organization was inaccurate. I believe I mentioned this when we spoke last time.

While initially completing the Statement of Organization, I was unclear as to whether the PAC should display the Elizabeth Furse for Congress Committee as an affiliated committee. I consulted on this issue with an FEC analyst who suggested that we not include the Furse for Congress committee as an affiliated one. I think they made this suggestion because we had not discussed the way that the Tribal Sovereignty PAC was expecting to meet its requirement for multi-candidate status and the fact the Furse for Congress committee was shut down and filing a closing report. After speaking with you, however, it became clear to me that this was an error, and the Furse for Congress committee does need to be recorded as an affiliated committee.

I had responded to the inquiry letter about our Statement of Organization before we spoke, however. I hope that this explanation and the enclosed copy of Tribal Sovereignty PAC's Statement of Organization will clarify this one particular issue.

Enclosed you will also find an amended copy of Tribal Sovereignty PAC's Multicandidate Status Form.
