Dear Ms. Benitz: Rock City PAC (FEC ID# C00436410) is in receipt of your Request for Additional Information dated August 23, 2013, concerning the PACs 2013 July quarterly FEC report. Your letter references receipts reported from the International Council of Shopping Centers (ICSC) PAC and TrustMark Insurance Company PAC. We have confirmed that the contribution from ICSC PAC was from their federal account and it was reported correctly. We have been notified by TrustMark Insurance Company that their donation was not issued from their PACs federal account, and we have amended our report to reflect this receipt on line 11ai. We refunded this donation on September 25, 2013, and will include this refund on our next FEC report. The donation of \$ 10,000 to the Tennessee Republican Party (TRP) was actually a donation of \$ 5,000 to the TRP federal account, and \$ 5,000 to the TRP non-federal account, and our amended 2013 July quarterly report reflects these corrected entries.
