This Committee responds to the September 26, 2016 RFAI, with response due October 31, 2016, as follows: 1. This report has been amended to provide updated year-to-date per election totals for Schedule E. 2. The expenditures to Campaign Solutions and to Connell Donatelli, Inc. were properly and timely disclosed as part of the June monthly estimates filed 6/3/16: Transaction IDs SE24.84750 and SE24.84752 on FEC-1076060. Note that this latter record listed the vendor slightly differently from the initial 48-hour report; this report has been updated to match the initial 48-hour report. With respect to the expenditures to MDS Communications, the Committee had previously worked with a different vendor for outbound phone services, and due to some confusion as to which vendor was providing these services for June, the estimated 48-hour report did not include the intended estimate for this activity. 3. Due to normal fluctuations in Committee program activity, expenditures included in monthly estimates are occasionally different from the estimated amount, or are never actually made. In cases where an expenditure is never made, that is, where the actual amount spent is \$0.00, the Committee does not include it on Schedule E of the corresponding periodic report. Two of the expenditures at issue here were never actually made, and so have not been included on Schedule E of this report; the expenditure to CD, Inc. was made, and was included on the Schedule E, though with a slightly different vendor name, as detailed above. Also in this amendment, the above-referenced expenditure to CD, Inc. has been broken up into three separate items; the two independent expenditures disseminated in May but not paid for until June were invoiced together with the June activity, and the total payment was originally reported as a single item. The items from Schedule D of the June monthly report for these cross-month expenditures have been added to this report, and updated to reflect the final payments.
