-Schedule A supporting Line 17 of your report failed to provide the aggregate year-to-date amount. Please be advised that federal regulations require aggregate year-to-date totals for all receipts received during the calendar year.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
