This documentation provides evidence of contributions. The donations were amended to be non-itemized. Item 2. The contribution of Cones is not from a corporation, but is from a political campaign not registered with the FEC. Item 3. Contributions from the Nick Long Campaign and the Tommy Cones Campaign were received from political organizations not registered with the FEC. The Galveston County Republican Party immediately reviewed the donations upon receipt of the request for information and upon confirming that the donating organizations were not registered with the FEC, the donations were promptly returned to the donors. Records of the return checks and memoranda are available for review. Cash on Hand- Will now only reflect the Federal Account Balance. The cash on hand will be amended on previous FEC filings beginning with Jan 1, 2022 balances. Only receipts and disbursements from the Federal Account will be shown in the amended reports and futue reports. The difference in cash on hand with bank account due to timing of deposits and dispursements.
