This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-The totals listed on Lines 23 and 30, Column B of the Detailed Summary Page(s) appear to be incorrect. Please be advised that you should add the "Calendar Year-to-Date" total from your previous report to the current "Total This Period" figure from Column A to derive the correct Column B totals. Please amend your report and any subsequent reports that may be affected by this correction.

-The beginning cash balance of this report should equal the ending balance of your 2002 April Monthly Report. Please clarify this discrepancy and amend any subsequent report(s) that may be affected by this correction.

-Your calculations for Line 7, Column B appear to be incorrect. FEC calculations disclose this amount(s) to be \$177,782.22. Please provide the corrected total(s) on the Summary Page.

-Schedule B supporting Line 23 of your report (pertinent portion attached) discloses a contribution to Nancy Johnson for Congress. However, you have indicated 4/9/2006 as the date of disbursement for this contribution. Please amend your filing to clarify this discrepancy or provide further information.

A response or amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter. Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
